

**THE CORPORATION OF THE TOWN OF PERTH  
BY-LAW NO. 4029-7**

**A By-law to amend the Water and Sewer By-law with respect to Rates Charged**

**WHEREAS**, The *Ontario Municipal Act, 2001, S.O. 2001, c.25, as amended*, confers broad authority on the municipality to enable the municipality to govern its affairs as it considers appropriate and further states that a lower tier municipality may provide any service or thing that the municipality considers necessary or desirable for the public, subject to the rules set out in subsection 11 (4). 2006, c. 32, Sched. A, s. 8.

**AND WHEREAS**, Council has reviewed Report 2025-COUNCIL-3.2 and concurs with the staff recommendation to revise the fixed fee associated with the 3" and 4" dial size that were incorrectly stated in By-law No. 4029-6.

**AND WHEREAS**, Public notice of the revisions to water and sewer charges has been provided.


**NOW THEREFORE BE IT RESOLVED THAT**, the Council of The Corporation of the Town of Perth enacts the following:




**Note:** Sewer flat rate applies for those residential accounts connected to municipal sewer but not water services.

**Sewer Collection Rate (extraneous flows)**

\$ 5.22 per 1000 Imp Gallons

**Note:** Sewer Collection Rate applies for non-residential sewerage resulting from private water sources (e.g. ground-source wells), to be metered either by proxy from well records or directly through sewer flow monitoring, at the discretion of the Director of Environmental Services or designate.

**Process Cooling Water Surcharge**

150% of Water Consumption Charge

**Note:** Process Cooling Water Surcharge applies for non-residential sewerage resulting from process cooling water, to be metered directly through on-site sub-metering.

**Bulk Water Sales**

See Schedule A - By-law 3675

**Bulk Wastewater Disposal**

\$ 63.92 per 1000 Imp Gallons

**Note:** Limited bulk wastewater disposal is available at the discretion of the Director of Environmental Services or designate.

**Rural Surcharge**

50%

**Note:** A rural surcharge is calculated as a % of the Total Charges, excluding Sprinkler Charges.

**Septage Hauler Dump Rate**

\$ 7.87 per 100 Gallons.
