**THE SUBJECT LANDS** are legally described as Lot 7, Plan 27M3, Town of Perth and are municipally known as 45 Decaria Boulevard in the Town of Perth. The lands are currently zoned R1 and accommodate an existing single detached dwelling.

THE PURPOSE & EFFECT of the application is to permit the construction of a shed in the rear yard for storage use. Variances requested include permission for lot coverage of approximately 39.76%, whereas Section 4.27 of the Zoning By-law does not permit additional lot coverage on the site over and above what was provided as of March 22, 2005 (37%), as well as a

reduced rear yard setback of 1.05 m for an accessory structure, whereas the Zoning By-law requires 1.2 m.
