NOW THEREFORE, the Council of the Corporation of the Town of Perth hereby enacts as follows:

1. Authorization:

- 1.1. Amend Schedules 'A' through to 'F' to annually increase the fees based on the Consumer Price Index (CPI), rounded up to the next ten cents (\$0.10); with the exception of:

- 1.1.1. Late Payment Charges on Taxes;
- 1.1.2. Utilities and Accounts Receivable;
- 1.1.3. Utility Holdbacks;
- 1.1.4. Lottery Licenses;
- 1.1.5. Planning Security Deposits,
- 1.1.6. Busking Permit Fees; and,
- 1.1.7. General Administration Fees.

- 1.2. That all users be allowed to pay for the fees and charges in Schedule 'A' with a credit card.

2. Schedules:

That all Schedules will be amended on an annualized basis (October to October timeframe) to reflect changes as per the Ontario Consumer Price Index (CPI) with the exception of Schedule C fees which will be reviewed on an annual basis to ensure they are competitive with surrounding municipalities and reasonable within the context of services being provided.
