- Undertake maintenance of the Quality Management System to ensure the accreditation remains current as outlined by provincial legislation,
- Coordinate and participate of internal & external audits, document and records control, prepares appropriate reports, investigates and implements corrective actions and develops and implements contingency plans as required,
- Prepare Summary, Annual, and quarterly DWQMS reports to Committee.
- Establishment and maintenance of the municipality's Consolidated Linear Infrastructure database and environmental compliance records.
- Support for the operations of Roads and Surface systems related to:
- The Minimum Maintenance Standard in areas of winter control, roads, sidewalks, and parking lots
- Waste Management:
- Maintains records pertaining to solid waste collection, recycling and solid waste disposal site operation, household hazardous waste and other waste management programs.
